1. 2. Approval of February's Minutes-Keith Dirks moved to approve, 2nd by Ivan Eden, motion carried
3. Committee Updates (Join a committee/project!)
 - a. Policy- Getting the word out about Social Host- John K- Third reading was this week, and was approved by local supervisors. After it is published in the paper next week, it is law. Jennifer handed out brochures about this issue. The policy committee is hoping to make it more professional looking to distribute to the community. Marketing will take a look at it.
 - b. Planning/Chairs- next steps with “projects” – Jennifer reported that at their last meeting they tried to come up with ideas to help committees work together more efficiently. A pilot project focusing on a Marijuana prevention message to the community will be done to see how the new process will work. They will meet on 3/17 at noon with lunch provided.
 - c. Fundraising- Some networking was done about various grants and donations for the BEASTS group. Dawn is working on getting donations of games and other items for the upcoming BEASTS event.
 - d. Marketing- Bill N. –they met and approved a new form to be given to all other committees who want any help from Marketing to implement their committee ideas. They are looking into alternatives for Marketing at the fair, since we won't be having a booth.
 - e. BEASTS-Jacki- Now meeting 2 times per month for planning school marketing efforts and 4/20 event here at the Coalition office, They are making posters with actual Jones Co. stats ‘Majority Rules’ campaign, to let people know what kids do instead of use substances. Ashley reported that she has been to Monticello Middle Schools to talk to kids and is going to Anamosa tomorrow, and has scheduled times in Midland and Olin for next week.

7. CADCA Academy highlights- Jacki reported that she went to training in Des Moines and attended workshops and learned some valuable info and recommends for coalition members. She also noted that our community needs to do another needs assessment as our last one was a long time ago.

9. SPF SIG- Strategic Prevention Framework State Incentive Grant- See webinar dates below. It is anticipated Jones Co. will receive funding to help address adult binge drinking and underage youth drinking, which will include having a full time person here to work on this with the community.
10. Tobacco prevention: Kick Butts Day—March 23- It was reported from Amy that she has been working with the student advocacy groups on making sure they are doing awareness activities in their schools that day. We'll also have some information available in the coalition office as we have the SPF SIG Webinar.
11. Accomplishments for past month: \$12,800 worth of in-kind hours and donations were collected in Feb. Celebration applause was given for the fact that the Social Host ordinance passed in Jones County! Also both Mixers were well attended in Midland and Monti with 170 people total between the two events. The evaluations were very positive and we will consider what next steps these events produce for our coalition efforts.
12. Other Sharing? County Supervisor Keith Dirks will be going to Des Moines to talk to State legislators, and will be sharing concerns on issues with them. The Coalition office is in need of some remodel work. Any construction talent to donate? Still looking for law enforcement to take TIPS training either March 20 and 21, or April 18 and 19. Hope to be offered to businesses before next round of alcohol compliance checks prior to Graduation season.
